ADMISSIONS & TUITION INFORMATION (All classes are subject to a space available basis) \$50 application fee (per student capping at \$100). Application fee is applied toward tuition if student enrolls. \$900 tuition per year per child

Tuition may be paid in full or by semester. Tuition is due within 5 days of acceptance into the program. Admissions paperwork needed: Registration form, Student Academic form, Pastor reference, Birth certificate, and immunization records.

TUITION REDUCTION

- Tuition assistance may be available for families who enroll three or more students.
- SCRIP—Merchant gift cards are sold on Monday and Friday mornings at our Holy Grounds Café. Homeschool parents may also purchase SCRIP on Wednesday's in the administration office. Paydown (tuition credit) for SCRIP occurs in August and December for homeschool families as they pay for the upcoming semester.
